Regional Stormwater Management Coordinating Council Special Meeting - TSI Cost Share Request

1. Welcome and Introductions.

PRESENTATION ITEM

- 2. Special Presentation on the Integrated Transportation and Stormwater Infrastructure (TSI) Initiative.** NCTCOG will give a presentation on the TSI initiative and request to incorporate project support into the FY25 Regional Stormwater Management Program Work Plan to add TSI North Project Support, along with funding support, allocated out of deferred revenue from prior RSWMCC annual budgets.

NCTCOG Environment and Development Director, Susan Alvarez, and Program Supervisor, Kate Zilke, gave a special presentation to Regional Stormwater Management Coordinating Council (RSWMCC) members on the Integrated Transportation and Stormwater (TSI) initiative. Through the TSI initiative, the region will be able to integrate stormwater management, urban development, transportation, and environmental planning. This effort will also help identify impacts and alleviate risks from flooding, aid in getting ahead of regional growth, and reducing costs. In total, the initiative includes two study areas across the region that impact 85 cities and 8 counties. The West study area covers portions of Ellis, Johnson, Tarrant, Parker, and Wise counties. The North study area covers portions of Denton, Tarrant, and Wise counties.

The TSI Initiative is expected to provide MS4 Permit compliance support for RSWMCC members in relation to the MCM for post-construction controls for both Phase I and Phase II communities. Deliverables will include recommendations for related policy, ordinances, and implementation. A survey of RSWMCC members in 2019 indicated that members find the MCMs for Construction Site Stormwater Runoff and Post-Construction Stormwater Management to be of top concern. A survey of PETF members in 2024 about the renewal of the Small MS4 Permit showed a majority of respondents plan to specifically address Developers or Construction Site Operators to help them meet MCM 1 requirements. Anticipated outreach around the TSI project may also be used to address these concerns.

The presentation included a request to officially incorporate TSI north study area project support, along with funding support, into the FY25 Regional Stormwater Management Program Work Plan. Funding support of \$45,000 was requested to be allocated out of the deferred revenue fund for the Regional Stormwater Management Program from prior RSWMCC annual budgets. This funding support would be part of the local fund match, of which the Public Works Council and Trinity River COMMON VISION Steering Committee are also contributing as project partners.

ACTION ITEM

- 3. Vote to Amend FY25 Work Program and Grant Funding Request.** A call for a vote by members will be held to amend the FY25 Regional Stormwater Management Work Program to include support of the TSI North Project and grant use of program deferred funds to be used as local fund match.

Following the presentation and time for questions from RSWMCC members, a motion was made to approve amending the FY25 Work Plan to incorporate coordination with the integrated Transportation and Stormwater Infrastructure study and authorize the use of deferred Regional Stormwater Management Program funds. Specifically, coordination may produce: model ordinances, outreach materials, strategies that could reduce flooding and pollution including post-construction controls, and recommendations to fund stormwater management activities.

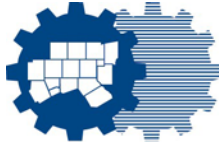
