
### FY2022 Trinity River Common Vision Work Program NFIP/CDC Model Consolidation Effort

The USACE funded two ongoing studies related to CDC model consolidation.

- Updating the newly georeferenced CDC model with approved but not yet constructed CDC project geometries from 2017 onward and future flows.
  - Draft model is being coordinated with FEMA Region 6.
  - Working collaboratively to generate a consolidated CDC/NFIP model.
  - Will share draft model for FMTF review and feedback soon.
- Working to generate CDC future flows for the FEMA detailed study on the East Fork Trinity and the Trinity mainstem to ultimately extend the consolidated CDC/NFIP model.
  - Met with NCTCOG and updated future land use data delivery is imminent to inform subsequent hydraulic modeling
  - Discussed strategy with NCTCOG and FEMA Region 6.
  - Anticipate sharing with FMTF for review in 2023.
- The USACE set aside \$485,000 from the Floodplain Management Services (FPMS) fund to complete these scopes. Internal coordination at the USACE is occurring and additional data and information will continue to be shared with FMTF members.



### FY2022 Trinity River Common Vision Work Program NFIP/CDC Model Consolidation Effort



#### Methodology:

- Added latest CDC projects (since 2017) to the model.
- Reviewed and incorporated latest FEMA LOMRs, as appropriate.
- Consolidated model will include latest CDC and FEMA. geometries and flows
- To share draft model for FMTF review and feedback soon.

- The NFIP-CDC Model Consolidation Team had a meeting on July 22nd to continue work on the 5<sup>th</sup> edition update.
  - Completed final drafts of the following sections and forms: Section 1: Introduction and Section 2: CDC Regulation & Criteria, Section 3: The CDC Process, and the Application, Final Action, and Extension forms.
  - Completing revisions to Section 4: CDC Submittal Requirements, the Verification form, the Appendices and the FAQs
- The Team will meet next in September to finish review of the Sections, Forms, and Appendices
- Upcoming meetings will discuss final compiled draft of manual and comments
- Updates will be brought to the FMTF throughout the process and your feedback will be requested.







- FY19 Flood Risk Projects
  - Harriet Creek (Denton County, 7 miles) Hydrologic and Hydraulic analysis is complete. Final mapping is in progress; TSDN is being prepared.
  - Waxahachie Creek (Ellis County, Midlothian, Waxahachie; 19 miles) Hydrologic and 89% Complete Hydraulic analysis is complete. Final mapping is in progress; TSDN is being prepared.
- FY20 Flood Risk and Outreach Projects

    53% Complete underway. Preliminary mapping is in progress.
- FY21 Flood Risk Projects

  - East Fork (Lowery Crossing and McKinney) Terrain Data Capture and draft TSDN are 3% Complete underway.


