NFIP/CDC Model Consolidation and Extension Efforts

FY2023 Trinity River Common Vision Work Program

NFIP-CDC Model Consolidation and Extension Efforts

The USACE funded two ongoing studies related to CDC model consolidation.

1. Updating the newly georeferenced CDC model with future flows and approved but not yet constructed CDC project geometries from 2017 onward.

- USACE and FEMA worked to update their respective models and posted consolidated NFIP-CDC model to the Trinity River CDC website.
- Culmination of a collaborative effort to generate a first-ever consolidated NFIP/CDC model.
- Aligns with NFIP/CDC manual updates and incorporates FMTF review & feedback.

FY2023 Trinity River Common Vision Work Program

NFIP-CDC Model Consolidation and Extension Efforts

2. Creating CDC future flows for the FEMA model on the East Fork Trinity and the Trinity Mainstem to extend the consolidated NFIP-CDC model.

- Incorporated NCTCOG guidance on future land use data to inform hydrologic modeling. After developing flows, will complete hydraulic model for this area.
- Anticipate sharing with FMTF for review in 2024, continued funding permitting.
- Consolidated NFIP-CDC model was approved at the May FMTF meeting and posted to www.TrinityRiverCDC.com.

FY2023 Trinity River Common Vision Work Program

Floodplain Development when NFIP-CDC Model isn't Available

- **Discussion Context:** We're receiving questions about how to manage floodplain development in communities that join CDC/COMMON VISION but do not yet have an approved NFIP-CDC Model.
 - Want to ensure we provide consistent guidance
 - Example scenario is Seagoville:
 - They've joined COMMON VISION but a Consolidated NFIP-CDC model is not yet available (only NFIP Prelim/Effective models are available).
 - Will include this guidance in forthcoming 5th Edition of the CDC manual.
- One separate but related discussion topic is the future process for extending these models, particularly for communities that aren't directly located on the Trinity or one of its primary tributaries.

CDC Manual Update to the 5th Edition

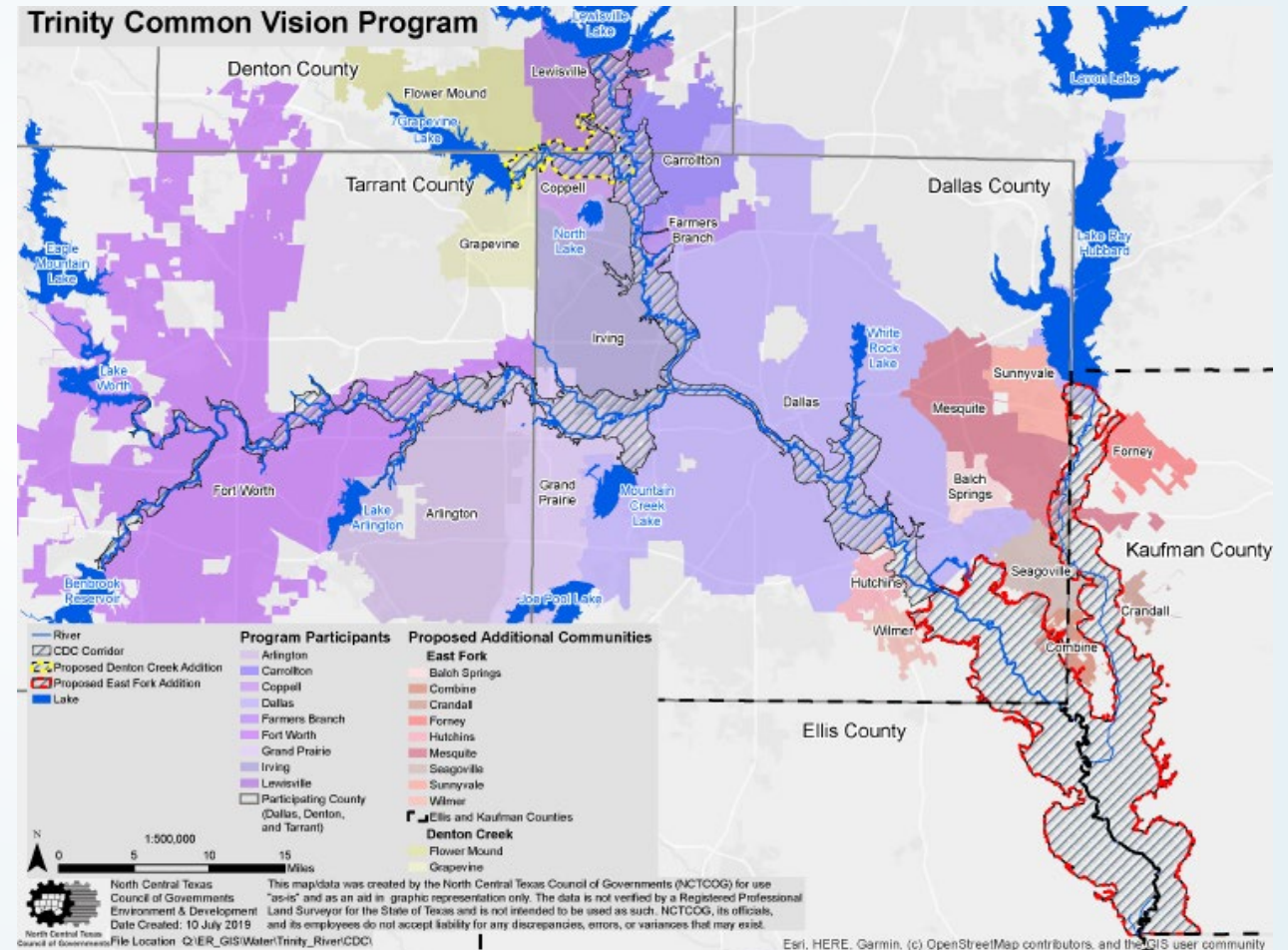
- NCTCOG and NFIP-CDC Model Consolidation Team working to compile into a draft of entire manual document.

USACE - TRINITY OPERATIONS STUDY



PURPOSE AND SCOPE

- Ground up approach to identify flexible USACE reservoir operation plans to better serve the reservoir's authorized purposes and stakeholders.
- Several phases including an Outreach and Planning Phase, Modeling and Analysis Phase(s), and Water Control Manual codification.
- The goal of the project will be to understand system weaknesses and maximize flood damage reduction and water supply benefits by re-evaluating the Reservoir Operation Plans stated in the Water Control Manuals.
